

HANSON COUNTY DRAINAGE BOARD
MINUTES OF PROCEEDINGS
Tuesday, April 5, 2022

Chairman Fox called the meeting of the Hanson County Drainage Board to order on Tuesday, April 5, 2022 with members Bumgardner, Kjetland, Schoenrock, Waldera and present. The Drainage Administrator was also present.

Motion Kjetland, seconded by Waldera to approve the agenda. Motion carried.

Motion Schoenrock, seconded by Bumgardner to approve the March 15th meeting minutes. Motion carried.

Tom Bannwarth was unable to make today's scheduled agenda item. The topic was discussed and tabled until April 19th.

Motion Kjetland, seconded by Schoenrock to approve permit #22-02 for Millbrook Colony to Tile in the E2 of 21-104-59 as the following conditions have been met: Project does not affect govt property; does not drain a fish or wildlife lake; does not impact a meandered lake; does not affect another county; converts noncontributing land to contributing land; erosion will decrease or be minimal; water quality and supply will be better; ag production will improve; environmental quality will improve; aesthetics will improved; fish and wildlife values will be minimally affected; receiving watercourse does have sufficient capacity; drainage is a reasonable improvement; drainage is a reasonable artificial drain system; amount of water drained is reasonable; design and aspects of the drain are acceptable; sustained flow will be acceptable. Motion carried.

Motion Bumgardner, seconded by Waldera to approve permit #22-03 for Thomas Freidel to Tile in the NW4 of 30-101-58 as the following conditions have been met: Project does not affect govt property; does not drain a fish or wildlife lake; does not impact a meandered lake; does not affect another county; converts noncontributing land to contributing land; erosion will be minimal; water quality and supply will be better; ag production will increase; environmental quality will improve; aesthetics will improved; fish and wildlife values will not be affected; receiving watercourse does have sufficient capacity; drainage is a reasonable improvement; drainage is a reasonable artificial drain system; amount of water drained is reasonable; design and aspects of the drain are acceptable; sustained flow will have minimal impact. Motion carried.

Motion Kjetland, seconded by Schoenrock to approve permit #22-04 for Glen Henglefeld to Tile in the SW4 of 30-101-58 as the following conditions have been met: Project does not affect govt property; does not drain a fish or wildlife lake; does not impact a meandered lake; does not affect another county; converts noncontributing land to contributing land; erosion will be minimal; minimal affect to water quality and supply; ag production will increase; environmental quality will improve; aesthetics will

improved; fish and wildlife values will not be affected; receiving watercourse does have sufficient capacity; drainage is a reasonable improvement; drainage is a reasonable artificial drain system; amount of water drained is reasonable; design and aspects of the drain are acceptable; sustained flow is acceptable. Motion carried.

Motion Schoenrock, seconded by Waldera to approve permit #22-05 for Don Henglefeld to Tile in the E2 of 30-101-58 as the following conditions have been met: Project does not affect govt property; does not drain a fish or wildlife lake; does not impact a meandered lake; does not affect another county; converts noncontributing land to contributing land; no erosion; minimal affect to water quality and supply; ag production will increase; environmental quality will improve; aesthetics will be improved; minimal affect to fish and wildlife values; receiving watercourse does have sufficient capacity; drainage is a reasonable improvement; drainage is a reasonable artificial drain system; amount of water drained is reasonable; design and aspects of the drain are acceptable; sustained flow will be acceptable. Motion carried.

As there was no further business before the Board, a motion was made by Waldera, seconded by Bumgardner to adjourn meeting. All voted aye, motion carried.
