

HANSON COUNTY DRAINAGE BOARD
MINUTES OF PROCEEDINGS
Tuesday, May 10, 2022

Commissioner Fox called the meeting of the Hanson County Drainage Board to order on Tuesday, May 10, 2022 with members Kjetland, Schoenrock and Waldera present. Bumgardner was absent.

Motion Kjetland, seconded by Waldera to approve the agenda. Motion carried.

Motion Waldera, seconded by Schoenrock to approve the April 19th meeting minutes. Motion carried.

All hearing attendees signed in and took an oath. A list of attendees can be viewed in the Auditor's office.

Chairman Fox called to order the Bannwarth versus Plano Township drainage hearing. The purpose of today's hearing is to determine if James Bannwarth should be allowed to tile through a Plano township road as no signature from the township have been obtained on the permit as this is the township's common practice not sign to sign.

Tom Bannwarth was present to address the Bannwarth's request and concerns in order to complete the tile project. No one was present from Plano Township to present testimony.

After all questions and concerns from the audience were addressed, the hearing was closed. A motion was then made Waldera, seconded by Kjetland to approve an easement for James Bannwarth to cross the Plano township road (416th Ave.) with conditions to be added. All voted aye, motion carried.

Motion Kjetland, seconded by Waldera to approve and set the following conditions for the easement approved for James Bannwarth to cross the Plano township road: salvage the black dirt and reclaim and reseed the road right-of-way; maintain road surface for one year where the tile was buried; notify Sheriff and use proper road closed signage when the project is taking place. All members voted aye, motion carried.

Motion Schoenrock, seconded by Kjetland to adjourn the hearing. All voted aye, motion carried.

Motion Kjetland, seconded by Waldera to approve permit #22-06 for Ron Rose to Tile in the SW4 25-103-59 as the following conditions have been met. Project does not affect govt property; does not drain a fish or wildlife lake; does not impact a meandered lake; does not affect another county; converts noncontributing land to contributing land; minimal erosion; water quality and supply will improve; ag production

will increase; environmental quality will improve; aesthetics will improved; fish and wildlife values will improve; receiving watercourse does have sufficient capacity; drainage is a reasonable improvement; drainage is a reasonable artificial drain system; amount of water drained is reasonable; design and aspects of the drain are acceptable; sustained flow will be acceptable. All voted aye, motion carried.

Motion Waldera, seconded by Schoenrock to approve drainage permit #22-07 for Greg Kayser to Tile in the E2 27-102-57 as the following conditions have been met. Project does not affect govt property; does not drain a fish or wildlife lake; does not impact a meandered lake; does not affect another county; converts noncontributing land to contributing land; minimal erosion; water quality and supply will improve; ag production will increase; environmental quality will improve; aesthetics will improved; fish and wildlife values will improve; receiving watercourse does have sufficient capacity; drainage is a reasonable improvement; drainage is a reasonable artificial drain system; amount of water drained is reasonable; design and aspects of the drain are acceptable; sustained flow will be acceptable. All voted aye, motion carried.

Jim Davies, States Attorney, informed the Board that a hearing has been set for Tuesday, May 24th to resolve the Plano Road (247th St.) ditch issue and determine how this will be corrected.

As there was no further business before the Board, a motion was made by Waldera, seconded by Schoenrock to adjourn meeting. All voted aye, motion carried.
