Motion Kjetland, seconded by Fox to approve the July 11th meeting minutes. Motion carried.

No citizen input or board reports.

Christian Hammond was present from Brosz Engineering to explain the following bridge matters. Motion Kjetland, seconded by Schoenrock to approve and authorize the Chairman and Auditor to sign the following resolution applying for 2024 BIG funds. All voted aye, motion carried.

Bridge Improvement Grant/Local Federal Bridge Programs Resolution Authorizing Submission of Applications

Motion Schoenrock, seconded by Kjetland to approve and authorize the Chairman and Auditor to sign the Brosz engineering Utility Certificate for Project No. BRF 6414 (00) 22-3 indicating Mitchell Telecom and Central Electric have been notified of said bridge project and found no relocation of either utility necessary. All voted aye, motion carried.

Motion Kjetland, seconded by Fox to approve and authorize the Chairman and Auditor to sign the Brosz Engineering Right-Of-Way Certificate for Project No. BRF 6414 (00) 22-3 indicating no right of way or temporary easements are required for the construction of said project in Hanson County. All construction activity will take place within the existing right-of-way. All voted aye, motion carried.

Bid opening for bridge project BRF 6414 (00) 22-3, the preservation project of bridge #31-001-08 on Old Mill Road, will take place on September 19, 2023 and bids will be awarded on October 3, 2023. Both scheduled to take place at the regular commissioner meetings and organized by Brosz Engineering.

Justin Friese, Hwy Superintendent, did not attend today's meeting.

Motion Kjetland, seconded by Schoenrock to accept the resignation of Michael Carr effective July 19, 2023. All voted aye, motion carried. The Board wishes Michael well as he attends Southeast Technical College for diesel mechanics.

At the recommendation of Sheriff Wingert and subject to approval from the Ethan Fire Department and as no grassland fire danger currently exists, a motion was made by Fox, seconded by Kjetland to approve a firework display near Ethan, SD, on Saturday, July 29, 2023. All voted aye, motion carried.

Lyle Peters, A-1 Developers, scheduled to discuss the current happenings of the soybean plant developing in Davison County was unable to make today's meeting due to illness.

The completed departmental budget requests, provisional budget and projected revenue for 2024 were present to the Board and further review of the budget will continue to take place at the next several meetings.

Motion Kjetland, seconded by Schoenrock to recess Board of Commissioner to conduct business as the Drainage Board. All voted aye, motion carried.
