## HANSON COUNTY COMMISSIONERS MINUTES OF PROCEEDINGS Tuesday, August 1, 2023

Chairman Waldera, with members Bumgardner, Fox, Kjetland and Schoenrock present, called the regular meeting of the Hanson County Board of Commissioners to order on Tuesday, August 1, 2023.

The Pledge of Allegiance was recited.

Motion Schoenrock, seconded by Bumgardner to approve the agenda. Motion carried.

No conflict of interest or citizen input.

Motion Kjetland, seconded by Fox to approve the July 25<sup>th</sup> meeting minutes. Motion carried.

The Auditor's account balanced with the Treasurer's account in the amount of \$3,092,864.57 in all county, state, civil, school, CD and trust accounts as of July 31, 2023.

Fees collected by the Register of Deeds for July 2023 totaled \$3,463.00.

Commissioner Bumgardner reported on the Dakota Counseling meeting he attended and expressed the need for involvement from anyone interested in this work.

Motion Kjetland, seconded by Fox to approve the purchase of a CAT bumper from Beadle County for \$1,500.00. All voted aye, motion carried.

Commissioner Fox reported on the surveying being done in his area that required drilling holes in the asphalt road to search for the pins.

The Hanson Conservation District agenda item concerning their 2024 budget request was postponed until September 5<sup>th</sup> to give the Conservation Board time to have a meeting of their own.

Motion Kjetland, seconded by Schoenrock to approve the following plat presented by Christi Pierson, Zoning Administrator. A PLAT OF TRACT B IN LOT 1 OF D. Discussion and review of the 2024 Provisional budget took place to prepare the budget for publication later this month.

The Board reviewed and discussed a possible drainage violation with Jim Davies, States Attorney. A letter will be sent notifying the landowner a permit is required.

Davies reported that the Supreme Court ruled in Hanson County's favor concerning Dakota Constructors conditional use permit.

Noxious weed letters are being prepared to send to property owners in violation.
